Announces Testing for the Position of Firefighter/Paramedic

The East Joliet Fire Protection District will be accepting applications to create an eligibility list for the position of Firefighter/Paramedic. The testing will establish an eligibility list that is good for two (2) years. Testing process will be as follows:

Application Available: November 3, 2022 7:00am 3:00pm

Application Deadline:

Tuesday, November 21, 2022 by 3:00pm

A written test will be administered **Saturday, December 10, 2022 at 09:00am**. Check in will be at 8:00am with doors being locked promptly at 09:00am for the test to begin at Hopewell Academies, 1009 S. Briggs Street, Joliet, IL 60433.

A 70% score on the written test must be obtained to continue to the next phase of the testing process. NO RECORDING DEVICES, CELL PHONES PORTFOLIOS, OR BRIEFCASES WILL BE PERMITTED INTO THE INTERVIEW ROOM. PLEASE LEAVE ANY OF THESE ITEMS IN YOUR VEHICLE. Oral interviews will be scheduled pending test results.

All applicants must be US citizens, a minimum of 21 years of age and cannot be 35 years of age or older, on written examination day of except as otherwise provided by Illinois Statute 70ILCS 705. All applicants must be Illinois State Certified Paramedics at the time of hire. Residency within the 50 mile radius of East Joliet Fire Protection District Station 51 required within 12 months of appointment. Applicants must have a valid driver's license and no felony convictions.

Candidates without Firefighter II or Basic Operations Firefighter certification must successfully complete the fire academy and obtain a Basic Operations Firefighter certificate issued by the Office of the Illinois State Fire Marshal as a condition of employment. The East Joliet Fire Protection District will assume the costs of the fire academy. Those who already holding a FFII/BOF at the time of hire may be exempt.

Preference Points: Documents relating to preference points must be submitted with application:

Veteran: Applicants who served in the United States military for at least 1 year and who were honorably discharged shall receive 5 points. Proof of such service must include a copy of Military Form DD-214 (long form) as proof of active service and evidence of honorable discharge at time of	Residents of the district will be awarded 1 point.
